Our last official rally will be Ms. Kimberly Alaniz's installation rally hosted by Peter and Star Grover on their farm near New Hope, PA - details on the website.



CLUB BUSINESS - 2020 WBCCI INTERNATIONAL — IBT Board & Region Officer meetings info

RJ - Since I was recently elected to Region 2 1st VP, I thought it might be a good idea to listen in to the meetings held this week, so I had an idea of how they worked. There were two Regional Officers Forums and an Executive Committee meeting.

In the first Regional Officers forum, they spent most of the time making minor wording revisions to the amendments to fix some unintended consequences that the original wording caused - for example, under the original proposed wording, it would have been possible for a member-at-large to hold a Regional office, which doesn't make a lot of sense. These kinds of detailed discussions are something that few people enjoy, but are necessary to ensure the club isn't causing problems for itself down the road.

Most of the second Regional Officers Forum was dedicated to discussing the proposed budget that included a dues increase. The Regional Officers vote on which proposed budget to recommend, but it's up to the International Board to make the final decision. No one was thrilled with a dues increase, but there didn't seem to be a lot of options for cutting that would get us back in the black - and those things would only work for a year or two. The very successful Zoom format prompted the Regional Officers to decide to meet every few months in the future.


For the Executive Committee meeting on Wednesday, I was only able to listen for an hour or so, but the meeting was primarily focused on some housekeeping issues - approving some new flags and unit name changes, getting reports from the committees, and approving some things that had already happened but had to be made official, such as cancelling the Loveland rally. None of these required much discussion.

Linda – I did watch the (new) Executive Meeting held on June 27. One of the items in discussion was WBCCI dues increase presented by Eric McHenry, 2nd VP. The dues increase was voted and approved starting with the 2021 dues year (for next year) to \$75.00. There were other items on the agenda but the dues increase was a large part of the meeting. A video meeting of the WDCU board of directors was held on June 14, 2020, to give President Jerry McConnell the club backing as a delegate for the IBT. Roll was called and a quorum of officers were present including: Jerry McConnell, Kim Alaniz, Danee Alaniz, Patti Galupo, Linda Moore, RJ Marquette, Erica Marquette, Diane Sheridan and Becky Weimer. Members also present were Rob Sunde, Mary-Lou Gatward, Dave Gatward, Al Owens, Nic Iverson, Danielle Herrmann. Absent were officers Greg Wilson and Joy Spahr.

Linda Moore moved to open the meeting; seconded by Al Owens. Jerry wished us well in staying healthy during the shutdown and regretted having to cancel the CKR and Winchester, VA, rallies and the cancellation of the Region 2 Rally and International Rally for 2020. Previous minutes and treasurer report were not presented.

- 1.) Update on Region 2 Charity Challenge: as of today (June 14th), \$885 has been pledged to the World Central Kitches. Let's get this to our \$1000 goal by the end of the month.
- 2.) Jerry congratulated RJ Marquette on becoming the Region 2 Vice President.
- 3.) Proposed Amendments to the WBCCI Constitution to be voted on by delegates at the IBT meeting online:

Amentment 1. Qualifications for membership in the WBCCI are as follows, ownership of a hard-sided Airstream product and payment of annual dues. Members who sold an Airstream may retain membership as long as they do not own another brand of RV except those used on a permanent or semi-permanent basis as vacation facility or home. Amendment 2. Delegates Meeting for IBT are open to all members. Voting strength per delegate is determined by number of dues paying members by June 1. Members-at-large are represented by region representatives. Amendment 3. For consistency, the phrase "units/clubs" will be replaced by "clubs" in all WBCCI documents.

Also presented was the slate of officers for the 2021 year for the IBT.

Members unanimously voted to accept these changes and the proposed slate of officers.

JOIN US / Renew – 2020 WBCCI Membership Renewal Information

It's time to pay your WBCCI and WDCU dues for 2020 which is \$66.00 (\$65.00 for WBCCI and \$1.00 for WDCU). The best and easiest way to do this is to go to the WBCCI web site and pay with a credit card. Here is the link. http://wbcci.org/component/rsform/form/12-renew-your-wbcci-membership. Life members of WBCCI and Affiliates of WDCU can send their WDCU dues to Diane or give them to her at a rally.

If you prefer, you can pay directly at a rally; cash or checks are both fine. If you choose mail, send a check for \$66.00 to Diane Sheridan, 15053 Greymont Dr., Centreville, VA 20120.

To be listed in the 2020 WBCCI Directory, dues need to be paid before November 30, 2019. If you have any changes to your Directory information, please note them on your renewal form or notify Diane.

WDCU Renewal Information - How dues are calculated during the year.

WBCCI membership runs for the calendar year, January 1st through December 31st. Renewals begin in August of the preceding year and can continue throughout the membership year. If you want to be listed in the Membership Directory, your renewal must be in the WBCCI office by November 30th of the preceding year.

If you renew after January 1st, at any time during the year, you will pay the full amount of \$65.00 plus \$1.00 for WDC Unit dues. But – if you renew after July 1st, you will also need to pay in full for the following year. So, if you don't renew for 2018 until July 10, for example, you will pay \$132.00 instead of \$66.00 and your dues will be paid through 2020.

If you don't renew at all in 2019 you can reinstate your membership if you renew in the first half of 2020.

It is easiest for everyone if you renew through the WBCCI office, whether by mail or online.

If you are an Affiliate member of the WDCU or a Life member of WBCCI, you can pay your Unit dues of \$1.00 per year for more than one year at a time if you pay it to the WDCU Treasurer/Membership person. So, if you give Diane \$5.00, it will be good for five years. Regular members of the unit can only pay one year at a time; again, it is easiest if you do this directly to WBCCI when you renew your WBCCI dues. If you are paying just Affiliate member dues to Diane it is important to address your checks payable to Wally Byam Caravan Club International, Washington D C Unit.

New members' dues are prorated if they join later in the year. There is a schedule on the WBCCI web site; after July 1st new members pay the prorated amount for that year plus the full amount for the following year.

WHAT DID YOU DO DURING THE COVID 19 STAY AT HOME ORDER by Rob Sunde

Hello happy campers of the WDCU. Remember when you were a kid in grade school, it seemed like at the beginning of each new school year your teacher would ask for a report on "How I spent my summer vacation". Some kids would be really prepared with glowing accounts of traveling the country with their family and seeing so many sights. Other kids were more along the lines of Cheech and Chong: "The first day of my summer vacation I woke up, then I went downtown to look for a job then I hung out in front of the drug store. The second day of my summer vacation" Well this is my account of "How I spent my winter vacation, by Robert Sunde".

Most of you know that I am a gearhead. I love all things on wheels and I can't seem to leave these things untouched. I figure that there is always room for improvement. You may recall that I did a bunch of changes to Gayle's Globetrotter when I got my hands on it. Those changes made it more "livable" for us. Well now here comes "SHAR", our 1998 Safari that we bought from Shar and Gordon Field last year. SHAR was a beautiful, fully polished trailer that was ready to go camping in. But, being a gearhead, I just had to change something right away, so she got some new shoes (wheels and tires) to doll her up a little. We made it through the camping season last year just fine. Now the season is over and Gayle started to make some noises about things that maybe we could change. Her biggest issue was that she wanted to remove the carpeting and replace it with some, as yet, undetermined substitute. Some of you may have tried to do this in your Airstream and found out that when these trailers are assembled, the carpeting goes in BEFORE any of the cabinetry, beds, galley, etc. Suffice it to say that there is still some of the original carpeting in SHAR although it is not visible anymore. I removed all of the galley, the bedroom and the front living area in order to get to as much of the old carpet out as I could. Oh yeah, did I mention that the people on the assembly line must have a contest to see who can use the most staples when installing underlayment and carpeting. At the current scrap price for steel (\$105.00/ton) I think that I might have been able to buy a case of beer with the staples I removed. Anyway, the first major step was accomplished. Next, I examined the subfloor and, not to my surprise, I find a couple of spots where there is some rot. So, I cut out the bad flooring and patch in some new material. When I put in replacement wood, I like to treat the bottom and edges with a sealer to mitigate possible future water damage.

SHAR had a perfectly good queen-sized bed however, access to one side of the bed required one of us (not me) to squeeze between the bed and the back-interior panel of the trailer. Over time, this proved to be problematic. The solution was to replace the queen bed with two twins. Now I get out my trusty graph paper (I love that stuff) and plot a new bed/storage configuration for the bedroom. After doing the layout, I procure some lumber (1x2's) and commence to construct new bed frames. This gives me the opportunity to use one of my favorite tools for joining wood together, a Kreig pocket hole jig. I bought this thing over 20 years ago and have used it many times in woodworking projects. I first constructed the curbside bed frame which now has three storage compartments. Next, I tackled the streetside bed frame. This was a lot more challenging because I had to allow storage under the bed which was accessible from an exterior hatch. I had to come up with something strong yet light weight. I settled on a framework of thin-wall steel tubing which I welded and bolted together. It worked very well.

While I was on that side of the trailer. I had to rework the wiring to the breaker panel and add an outlet at the back of the trailer.

WHAT DID YOU DO DURING THE COVID 19 STAY AT HOME ORDER by Rob Sunde (cont)

The next area of concern was the galley. I have the scars on the top of my head to prove that the galley sink was too far under the overhead cabinets. My solution was to move the sink away from the outside wall by 6 inches. This required construction of a new base cabinet to house the sink and stove. Since we were going to all this trouble, we decided to upgrade all the counter tops with Corian. The fellow who built all the new counter tops also built the new galley base cabinet. So now we have new counter tops and sinks in the galley and bathroom, plus a new top over the corner cabinet in the living area.

Remember how I said that this project was mainly to remove the carpeting? Now we had to decide what to put down for flooring. The first thought was some type of wood-looking planking. Then we thought - nay, that would make the inside look like we were in an 84 Lumber yard. Too much wood. We settled for a travertine marble looking, snap together laminate flooring. When it came time to install this, Wayne and Linda Moore happened to be visiting. Heh heh heh. I'll put Wayne to work. So, Wayne and I put down the underlayment and proceeded to install the tiles. It took us all day and the results were fabulous. (thank you Mr. Moore).

Things were coming together nicely and now I'm at the front of the trailer where the battery is located. Ours is a big, heavy, deep-cycle battery that, at some point, needs to come out of the front hatch. I just knew that someone, other than me, had looked at these batteries and decided that there had to be an easier way to get it out of the trailer other than lifting it out. I was right, someone has made a sliding tray to accommodate a battery. I bought and installed this tray and it works great. A worthwhile investment.

The last thing to do was to install all the counter tops/sinks and hook up the plumbing. I don't believe that I have ever told you how much I hate plumbing. I would rather crush my fingers in a vise than do plumbing. However, calling in a plumber to make the water connections was not an option. It seems as if there are no standards when it comes to plumbing connections. Some are compression, some are flare, and some are NPT. I always seem to get the wrong parts both the first and second time that I go to the hardware store. I probably jinx myself. Anyway, I finally got everything hooked up and my lovely bride, Gayle, and I are ready for more Airstream camping fun with Miss SHAR. Please feel free to visit and see the results. 
